



We would like to invite your dancer to audition for our NS Dance Studio Energy Performance Company! This company is designed for ages 6 and up! This company is uniquely designed for students that are dedicated and would like to be a part of the competitive dance environment with less time commitment or experience needed.

Requirements for Energy Performance Company:

- The students must attend the auditions on May 5th- May 7th, 2026 (*See Sign Up Form for exact dates, based on rising grade/level*)
 - Pre-register on the studio website under Company Auditions
 - If you cannot attend these dates, please reach out to the office@nsdancestudio.com
- Students must attend both weeks of Intense Summer Dance Camp (Rising 2nd Grade-12th Grade) in June 2026 or Mini Magic Dance Camp (Rising Kindergarten-1st Grade) in July 2026.
- Students must attend Ignite: Guest Artist Workshop August 14-16, 2026 (Price to be determined)
 - *If unable to attend, you will still be charged for Ignite per Company Policy.*
- There will be a Company Bootcamp August 11-13, 2026
 - It will not be every day of that week, and a schedule will be posted closer to the date
- Students must be enrolled in the style of dance in which they will compete. The Faculty will decide on the style of dance after auditions. In the past, Energy Company has competed with Jazz, but there is the possibility for other genres too.
- Ballet and Jazz will be required classes in the fall in addition to the style of dance they will be competing in.
- The Energy Performance Company will learn 1-2 dances to compete. These dances will be taught during weekly regularly scheduled weekend rehearsals that will begin in early September once music is finalized. **These rehearsals are required attendance unless pre-approved by the lead Faculty Member for the company.**
 - If we have enough company members, we can create a class for them, which would allow any weekend rehearsals to be more occasional. We were able to do this for this last year, but it is not guaranteed.
- Energy Company Members must attend all scheduled competitions and performances. Dates of these competitions/performances will be announced as soon as possible. They are usually in January-early April. Competition dates are announced after auditions, as many competitions do not publish their dates until Mid-June/Early July.
- Energy Company is always invited to participate in Deck the Heights each year and certain Master Classes.
- Energy Company Members will be required to sign a Company Contract upon making the team.
 - Additional Requirements will be outlined in the contract
 - All Company Members are required to be on Auto-Pay for the entire 2026-2027 year.

Financial Obligations for the Energy Performance Company:

(These financial obligations are in addition to your monthly tuition, registration fee, recital costumes & recital fee.)

Note: Prices are subject to change, as these numbers are to give you an idea of the financial commitment and reflect prices during the 2025-2026 Season.

- Company Jacket (\$80)
- Yearly Energy Performance Company Fee (\$115.00, Due on June 5th)
- Company T Shirt (Included in the Company Fee)
- 1 Company Costume (Up to \$250.00) - A company costume deposit of \$150 will be due on July 1
- Costume Stoning Fee (\$30-\$50 - depends on costume)
- Two to Three Local Competitions (Within Driving Distance- possibly Montgomery/Huntsville)- Fees Vary (Competition costs vary - Up to \$150.00 each)
- Choreography Fee (\$200.00)
- Company Make Up (Varies; Studio Specific Lipstick & Liner Required \$20)
- Company Earrings (\$10-15)
- Prop Fee (Varies) (Dance may or may not have a prop)
- Company Banquet Fee (\$70.00 Dancer Fee *Dancer fee is mandatory for all dancers, even in the event they cannot attend the banquet; Parent Fee \$50 per parent attending)
