*A 20% discount will be offered to all siblings. Specialty classes are not discounted, and include Acro, Dance Team, Floor Barre, & Adult classes.

Tuition is based on a yearly fee that is divided into ten equal monthly payments. Your monthly payment is not related to the number of classes in the month. When you enroll, you register your child for an entire season of classes (30 Classes) **August through May**. May tuition is due in mid-April prior to recital. Even though you enroll for a season, we do allow you to drop at any time with a 30-day notification via the online Drop Form. You are responsible for ALL fees that are due in that 30-day drop period. The number of classes that occur in any given month depends on the calendar and any holidays or breaks that may take place during that month. Tuition is not prorated due to absences, weather, or scheduled closings. Liberal makeup classes will be available. Private lessons are available upon request at a rate of \$85/hour plus a \$15/hour studio rental fee.

A late fee of \$20.00 will be assessed for accounts not paid in full by the 10th of each month. Accounts with balances of \$200.00+ or 60 days past due will be charged a 15% late fee on what is due, and the student will not be allowed to return to class until an agreement has been reached. ALL students accounts must have a credit card on file but are not required to enroll in auto pay unless on NS Company.

Automated payments will be processed on the 1st of each month. Automated tuition payments may be made with the use of your debit/ credit card. You are required to give the studio one month's notice via email (office@nsdancestudio.com) to discontinue classes and/or drop a class (\$10.00 charge to change class schedule). Tuition is not refundable or transferable. The commitment will stop 30 days after the written notice is received via email. We reserve the right to automatically withdraw any family or student due to non-compliance of any studio policies. If auto draft is declined and we are not able to reach you by email or phone within 10 days of declined transaction, classes cannot be attended.

NS Dance will not give out information to anyone on students, their schedules, studio events, or any other important studio information unless that person is listed in your Parent Portal account. If there are additional parties (nanny, grandparents, etc.) that need to be able to receive information about a student, they must be listed in your Parent Portal Account.

Recital Fee:

NS Dance will showcase all of our wonderful students and the achievements they have made throughout the year with an end of the year recital. Recital fees help assist in the tremendous undertaking of putting on a first-class performance; e.g. theater rental, technical crews, additional staff, memory book class pictures. The recital fee also, includes, two complimentary tickets to one show, one recital t-shirt per child, recital video link, and one memory book per family. Please notify the office by September 1st if you do not wish to participate in Recital. This fee is due on February 1st, and is non-refundable.

Recital Costumes:

Students performing in the annual recital will be required to purchase one costume for each class they are enrolled. The first costume will be due on September 15th, and each additional costume will be due on the 15th of each month until all costumes are paid. All costumes must be paid in full by January 15th. Please notify the office by September 1st if you do not wish to participate in Recital. Once a costume has been ordered the costume fee will not be refunded; even if the class was dropped. Any costume not picked up by recital will be donated to a charitable organization.

Automated payments will be processed from your account on September 15th for the first costume. Each additional costume will be auto drafted the 15th of each month until all are paid. All students that require tights with their costumes will be charged \$15 and a pair of tights will be included with their costume when it is sent home.

2026-2027 Policies and Guidelines

Placement Policy:

All students will be placed in classes by the NS Dance Faculty accordingly. The office does not have authorization to place or change placement of any student. Students will be placed by ability and not the amount of time they have taken dance.

Attendance Policy:

In order for students to progress in their dance education and keep up with their class level, regular attendance is important. In the event that a student has to miss a class, an email must be sent to the instructor. Students who are constantly absent will tend to struggle in their advancement and may be dismissed from the class. If this occurs costume fees and/or recital fee will not be refunded. No more than three absences after January 1 due to the preparation of the annual recital.

Dance Attire Policies:

Students are required to wear the appropriate dance attire as stated in the guidelines. This enables the students to properly train in each discipline of dance and create a more uniform surrounding.

Pre-School & 5K Combo Classes	Solid colored leotard, Pink transition tights, Pink Revolution canvas ballet shoes, Dark Tan Revolution tap shoes
Acro/Floor-Barre	Fitted dance attire: Leotard or dance top, Booty shorts, jazz pants or leggings, no shoes or socks
Ballet	Solid colored leotard, Pink transition tights, Pink split sole canvas ballet shoes (Revolution, Capezio or Sansha), Ballet skirt or fitted warmers are permitted
Company Level Ballet	Solid black leotard, Pink transition tights, Pink split sole canvas ballet shoes (Revolution, Capezio or Sansha), Pointe shoes (if student is on pointe)
Hip Hop	T-shirts or tanks are permitted, leggings, jazz pants, sweatpants (length should cover the knee), Tennis shoes (For recital, you will have to purchase shoes. The instructor will let you know what to buy closer to pictures.)
Jazz	Leotard or dance top, Transition tights OR Booty shorts, jazz pants or leggings, Capezio Foot Undeez
Tap	Leotard or dance top or fitted tank top, Transition tights OR Booty shorts, jazz pants or leggings, Tan Bloch split sole tap shoes (Level A - Intermediate). For Level 5 students you will need black lace-up tap shoes (These can be full sole or split sole).
Contemporary	Leotard or dance top, Transition tights OR Booty shorts, jazz pants or leggings, Capezio Foot Undeez

Hair Requirement Policy:

All students should secure hair neatly off the face in a bun or ponytail. Short hair must be pulled back securely away from the face. All Ballet Students are required to wear their hair in a bun, secured with hairpins and a hair net. No ponytails are allowed in ballet.

I understand that dance instruction may require an instructor to physically touch a dance student during class time for the purposes of correcting dance technique, and I or my parent/guardian agrees to allow this touching, and hold harmless and release NS Dance Studio, from any liability regarding such.

I understand the risks of illness or injury from participating in any dance program. NS Dance Studio has put in place preventative measures to reduce the spread of illness, including, without limitation, sanitation policies and procedures and social distancing policies and procedures; however, NS Dance Studio cannot guarantee that you or your child(ren) will not become ill. Further, attending classes, rehearsals, and/or performances at NS Dance Studio could increase your risk and your child(ren)'s risk of contracting illness. I hereby waive, release and hold harmless NS Dance Studio, its directors, staff and heirs from liability or claim resulting from participation in classes, rehearsals, performances and any other related activities involved with the dance program. I acknowledge the risk of illness and voluntarily assume the risk that my child(ren) and I may be exposed to or infected to illness by attending classes, rehearsals, and/or performances at NS Dance Studio. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at NS Dance Studio or participation in NS Dance Studio programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless NS Dance Studio, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the NS Dance Studio, its employees, agents, and representatives, whether illness or injury occurs before, during, or after participation in any NS Dance Studio program. I give permission for NS Dance Studio to seek medical treatment for my child in the case of an injury or serious illness that requires immediate attention. I agree that if my child needs to be transported to an emergency facility that decision will be made by the emergency team responding to the situation.

I give NS Dance Studio absolute right and permission to use my child's photographs in its promotional materials and publicity efforts. I understand that the photographs may be used in publication, print ad, direct-mail piece, electronic media or other promotions. I release NS Dance Studio, their photographer, employees, agents, and designees from any liability for any violation of any personal and proprietary right I may have in connection with such use.

I understand that once my child's class has been dismissed, I am responsible for promptly picking up my child and hold harmless and release the NS Dance Studio, from any liability after my child has been released.

I understand that NS Dance Studio has the right to terminate my child's participation in the dance program at any time for any reason.
