



NS Dance Studio is excited for another great year of our Elite Performance Company! This company is designed for ages 6 and up! This company is perfect for students who are dedicated and refine their dance technique through increased class time in the studio and through both regional and out of town competitive and workshop opportunities.

## Requirements for Elite Performance Company:

- The students must attend the auditions on May 5<sup>th</sup>- May 7<sup>th</sup>, 2026 ([See Sign Up Form on studio website for exact dates, based on rising grade/level](#))
  - Pre-register on the studio website under Company Auditions
  - If you cannot attend these dates, please reach out to the [office@nsdancestudio.com](mailto:office@nsdancestudio.com)
- Students must attend both weeks of Intense Summer Dance Camp in June 2026.
- Students must attend Ignite: Guest Artist Workshop August 14-16, 2026 (Price to be determined)
  - *If unable to attend, you will still be charged for Ignite per Company Policy.*
- There will be a Company Bootcamp August 11-13, 2026
  - It will not be every day of that week, and a schedule will be posted closer to the date
- Students are required to take their designated ballet and jazz classes twice a week, as well as any other style they compete in.
- The Elite Performance Company will learn 3-4 group dances to compete. These dances will be taught during scheduled rehearsals to be announced. Weekly rehearsals will begin in once choreography is set. These rehearsals are required attendance unless pre-approved by a Faculty Member.
- Elite Company Members are eligible for solos/duos.
  - 1-Year of Company required to audition for solos/duos.
  - Solos/Duos are an additional expense that is not outlined below.
- Elite Company Members must attend all scheduled competitions and performances. Dates of these competitions/performances will be announced as soon as possible.
- The Elite Company will be required to sign a company contract
  - Additional Requirements will be outlined in the contract
  - All Company Members are required to be on Auto-Pay for the entire 2026-2027 year.

## Financial Obligations for the Elite Performance Company:

(These financial obligations are in addition to your monthly tuition, registration fee, recital costumes & recital fee.)

- Company Jacket (\$80.00)
- Company T Shirt (Included in the Company Fee)
- Company Costumes (Up to \$350.00 Each) A company costume deposit for up to 2 costumes of \$150 each will be due on July 1st, a second costume deposit for up to 2 costumes of \$150 each will be due on August 1<sup>st</sup>. Additional company costume balances will be due later.
- Up to four Competition/Conventions (Fees Vary) (Competitions Up to \$125.00 for each group dance & Convention/Competition- Approx. \$500-\$750 \*Does Not Include Travel Expenses\*).
- Choreography Fees (\$250.00) - Possibility of Guest Choreographers (Fee TBD by Guest Choreographer, and split between all dancers in group)
- Yearly Elite Performance Company Fee (\$275.00, Due on June 5th)
- Yearly Company Administration Fee (\$105.00, Due on June 5th)
- Costume Storing Fee (\$30-\$50 Per Costume)
- Company Make Up (Varies)
- Prop Fee (Varies) (Dance may or may not have a prop)
- Company Banquet Fee (\$70.00 Dancer Fee \*Dancer fee is mandatory for all dancers, even in the event they cannot attend the banquet; Parent Fee \$50 per parent attending)
